Information you give us:

#### Communication Information:

#### Verification Information:

If you wish to buy or sell lots, you may be asked for a scan or photograph of a valid proof of identification (government-issued photo ID). The information on your proof of identification, which clearly shows at least your full name, date of birth and ID (document) number, is required to verify your identity and help us to battle online fraud.

#### Other information:

We may ask you to provide us with feedback about our Service through an email or online survey. We greatly appreciate any feedback and will only process personal data (such as your email address or User ID) which may be collected by us or by our service provider for internal analytical purposes to enhance our Services.

#### WHAT DO WE DO WITH YOUR INFORMATION?
